The assessment of the fulfilment of the publication requirements takes place on the basis of the data entered into the MTMT and to the ODT database. In the case of publications with more than one author, the score is divided by the number of participants and rounded to a whole number.

Acknowledgement of a publication is certified by the advisor.

In the case of any fulfilment that cannot be placed in the categories listed in the table, the DSC makes the decision on whether to accept the publication and on the value of the credit on the basis of the recommendation of the advisor. Only the work performed in the given semester or the academic year may be taken into account.

Minimum publication requirements in the training and research phase (also a precondition for the complex examination)

Publication requirements in the thesis phase

Publication of a written work presenting the student's research in years 3 and 4 forming the basis of the thesis and/or a study linked to the topic, as follows:

If the masterwork cannot be published for any reason (e.g. confidential work, or if still being

Explanatory notes

Two "milestones": 16 credits, i.e. 4 4-credit subjects in years 1-2, and a further 16 credits, i.e. 4 4-credit subjects in years 3-4 must be completed.

When submitting the dissertation, the CV must include a list of publications.

The dissertation in Architecture is not based on a publication, but on a written text and a portfolio, with emphasis on the masterwork. There is no publication requirement beyond the publication requirements fulfilled during the training.

Not accepted as a publication:

- 1 conference abstract
- 2 conference lecture
- 3_workshop participation, round table discussion
- 4 participation in an exhibition and/or organisation of an exhibition
- 5_participation and award in a design competition (neither a news item announcing the outcome of the competition)
- 6 prizes, other awards
- 7_interviews by others

Additional rules

1_for multiple-author articles (including the masterwork), the credit value is divided by the number of authors

- 2_if the text of the publication of an architectural work (including the masterwork) is written by another author, the credits are divided in the given authorship ratio
- 3_publication in an edited publication counts as a publication only if it is about the masterwork or, in the case of a non-publishable masterwork, about another work (otherwise it counts as a reference)
- 4_a publication in progress but not yet published (subject to submission of a certificate) may be recognised only if it is necessary for the complex examination or for the pre-degree certificate.
